Res. Sir/Madam,

This is with reference to your proposal for continuation of affiliation for Academic Year 2023-24, vide letter no.1 submitted to the University and as per vide reference no. 2 Local Inquiry Committee was constituted and vide reference no. 3, with attached table mentioned the course/subject in column no. 2,3,4 are granted for continuation vide clause 114(1) under Maharashtra Public University Act, 2016 only for Academic Year 2023-24 and recommended for students admission in column no.5.

In this regard you are informed that the approval for Renewal of Affiliation/Natural Growth/Students admission to the subject/courses for the period (Academic Year 2023-24) as per the Table (Continuation & Natural Growth) is granted vide clause 114(1) under Maharashtra Public University Act, 2016.

You are also informed that, as per Maharashtra Public University Act, 2016, section 108, it is mandatory for you to fulfill the conditions suggested by the LIC for affiliation and accordingly you are requested to fulfill the mentioned conditions in respect of your college within two months but before submitting the proposal of continuation of affiliation for academic year 2024-25 with the compliance report along with necessary documents to the University's Affiliation Section. If you do not fulfill the conditions, no proposal for the affiliation of academic year 2024-25 will be entertained by the university. Kindly note that you will be solely responsible for the same.

If the college doesn't fulfill the criterion in regard with the full-time post of Principal, Librarian and Physical Director and 50% faculty recruitment, then the college has to submit the undertaking on non-judicial stamp paper of Rs 100/- to recruit the posts within two months. Continuation of affiliation/ natural growth and student admissions is granted subject to the fulfillment of above condition.

However vide ref.no.3 letter, the colleges which are notified first year and direct second year as 'No Admission' in the table are approved only the continuation of affiliation/ natural growth for the academic year 2023-24. Such colleges should not admit the students for the first year and directly second year. If the college submit the undertaking on non-judicial stamp paper of Rs 100/- in regard with the fulfillment of the condition the post of Principal, Librarian and Physical Director, or 50% faculty recruitment and the conditions of Local Inquiry Committee, then students admission will be considered. But the college will only admit the students after final approval of the university.

The colleges having the pending court cases proper action will be taken subject to the order of the Hon. Court.

You are requested to take necessary action about the same.
